ON 3-6TH MARCH TRANSMISSION HEARD USING TYPE PROCEDURE, ONE INCOMPLETE MESSAGE BEING PASSED. IN OPERATORS CHAT ONE PLACE NAME GIVEN IN FULL, OTHER PLACE NAMES DEDUCIBLE FROM CONTRACTIONS. IF INTERPRETATION OF THESE CORRECT IT GIVES IN THE PROPER ORDER, POINTS ALONG A POSITION OF KNOWN MCP COURIER ROUTE FROM PENANG VIA BETONG SALIENT TO PRESENT BELIEVED LOCATION OF SECRETARY GENERAL M.C.P.

2. FEDERATION STATE THIS NOT ANY POLICE OR SERVICE TRANSMISSION OR ANY TRANSMISSION LICENSED BY THEM.
3. PRESUMPTION THEREFORE STRONG THIS MUST BE M.C.P.
4. OPERATORS CHAT INDICATES POSSIBILITY TRANSMISSION WILL AGAIN OCCUR ON 17TH MARCH OR SUBSEQUENT DAYS.
5. SLIGHT T/A INDICATIONS POINT TO POSSIBLE CONNECTION WITH EARLIER UNIDENTIFIED TRANSMISSION PASSING 4 FIGURE TRAFFIC.

7. LOCAL EXPERT IS FORMER [REDACTED] WHO WAS IN LIAISON WITH FORCE 136. HE BROKE WITH MCP AFTER WAR AND WORKED AS [REDACTED] TILL EMERGENCY BROKE OUT. SINCE THEN HAS BEEN THEIR EXPERT ADVISOR ON M.C.P. AFFAIRS. HEAD [REDACTED] WHO HAS KNOWN HIM SINCE 1945 TRUSTS HIM IMPLICITLY.

8. OUR IMPRESSION IS THAT CYPHER MATERIAL PER SE IS PROBABLY INCOMPREHENSIBLE WITHOUT LOCAL EXPERTISE WHICH CAN ONLY BE PROVIDED BY ABOVE MENTIONED EXPERT.

9. SHORT TERM SOLUTION THEREFORE WOULD BE TO FLY IN SUITABLE [REDACTED] CRYPTANALYST OR AGREE TO BRING LOCAL QUOTE EXPERT UNQUOTE IN TO INDOCTRINATED RING. IN ANY CASE CRYPTANALYST WILL HAVE TO TALK TO "EXPERT".

10. AT THIS STAGE THEREFORE ANY FURTHER EXPLOITATION OR INTERPRETATION USING ANYTHING OTHER THAN PURE SIGINT RESOURCES WILL INVOLVE INDOCTRINATING "EXPERT" TO SOME DEGREE.
