REGARDING SIGINT SUPPORT FOR BORNEO OPERATIONS, SECRETARY HAS BEEN SITTING ON THE DRAUGEEE DRAFT MINUTE SINCE MONDAY. CORRIGAN RECEIVED SECS APPROVAL TO DISTRIBUTE MINUTE TOFDAY AND HAS DONE SO AND TO DATE HAS CGS APPRO TO IT. I HAVE YOUR COPY HERE AT MOMENT WHICH I WILL FORWARD TO YOU BY BAG TOMORROW. THERE IS SOME DOUBT IN CORRIGANS MIND AS TO WHAT ACTION THE SEC WILL TAKE ON THIS SUBMISSION. IE WHETHER HE WILL SUBMIT IT TO CABINET OR WHETHER HE WILL FORWARD IT FOR THE APPROVAL OF THE MINISTER TOGETHER WITH COPIES OF LETTERS TO THE TREASURY, EXTERNAL AFFAIRS, PRIME MINISTER ANFD THE ARMY.
