## INFUSE.

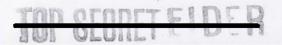
The attached papers on this subject call for some comment. It is apparent that the Effigy project (which is the large general-purpose computer being supplied by NSA) has top priority and that H in particular has only a minor interest in Colorob (his remark recorded at the top of page 7 of the minutes can leave no doubt of this). However the Director GCHQ effectively dispels any fear that DSB might be left holding a rather sick baby, and after a long discussion with Bob Botterill and John Duffill I can report that there is no lack of confidence here, In a general way the intention is to proceed precisely as planned i.e. install the machine and simultaneously organize and train the programming and operating personnel under Tony Eatway (who arrives in Melbourne on 5th September).

Detailed comment on the minutes is as follows:

- 4. Bob says that a decision to employ an operator has been taken but the post has not yet been approved. You will note that I Group's function in relation to the project has been neither accurately or fully stated: this may well be due to inaccurate minute-taking as the Director DSB is well aware of our responsibilities, as are most of the people concerned at GCHQ. For this reason I do not feel this is a point worth taking up but I would be grateful for your direction.
- 5(a) The Director BSB mentions "leaning on the programming experience of GCHQ". Both Bob Botterill and John Duffill say that it has been BSB's intention to be self-sufficient in programming and add that the programming team is a strong one even by GCHQ standards. It has been assumed that programming details will be exchanged between BSB and GCHQ and that GCHQ's advice will be available on particular issues, but this is not quite the same as "leaning on GCHQ". Bob says he has always envisaged BSB programs being written at BSB.

Bob emphatically disagrees with W65's comment about Infuse being employed on \_\_\_\_\_\_\_ for perhaps as much as two years using programs already written.

5(b)(i) I don't think H's observation that he had no firm requirement for a plugboard should cause any surprise: I always understood at GCHQ that Colorob was intended for fairly long jobs and so H only confirms the policy. There does not seem to be any action at this end until we see what Alan Bruce has to say, and in view of the Director's minute I feel fairly sure that GCHQ will take responsibility for producing the plugboards (perhaps by contract).

- 5(b)(ii) The multiplier seems to have been put in the "too-hard" basket. Tony doesn't say that a programmed multiplier uses too many of the machine's resources but if this is the case it might be easier and cheaper to provide more of the standard units. A reply has not been received to the letter sent to GCHQ on this subject. (You have a copy MH/RDB/067 of 28/5)
- 5(b)(iii), (iv) and (v) These will undoubtedly be problems in the future but there doesn't seem any point in getting too wrapped up in them at this stage.
- 6(d) Bob Botterill also disagrees with this: there are many other tasks.
- 7. I wonder whether we have given enough consideration to the Chairman's opening remark: Cecil Glass has frequently hinted at the same thing. If we have any adverse criticism to make it should perhaps be that the difficulties of bringing one machine into service whilst building another were not foreseen.

Returning to the general picture would you agree that none of this affects our immediate installation plans in any way? No doubt the Director, on his return, will be able to give us some background on "GCHQ's (changed?) position in the light of recent developments".

I have discussed the draft of this letter with Mr. Perrin who agrees with the contents and has promised to take up any issues for us. As the Director will be back next week he has suggested we might wait for his observations.

Is there any action you would like me to take on any aspect of this?
